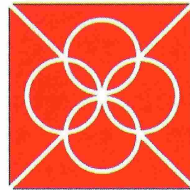

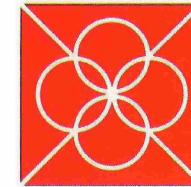

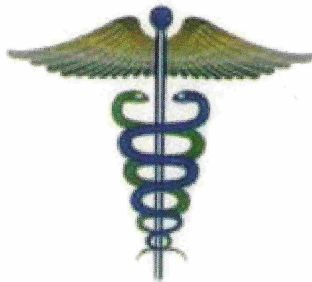

You qualify for Home Care if:

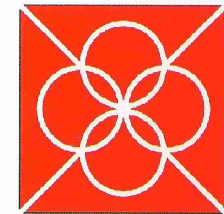
- * You are under the care of a Physician
